



Vendor Agreement
Fourth Annual Community Yard Sale

Saturday, June 2, 2018

The parties to this contract are the Nobody's Cats Foundation (NCF) (hereafter "Host") and _____ (hereafter "Vendor").

Whereas, Host is holding the Community Yard Sale at the rear of 3909 Hartzdale Drive, Camp Hill (Lower Allen Township) on 06/02/2018 from 8:00 am to 2:00 pm, and has the right to vend at and during the event, and

Whereas, Vendor desires to sell, display or distribute the following:

at and during the event,

Now, therefore, the parties agree as follows:

1. Vendor shall have access to the location **1 hour** before the event for the purpose of setting up Vendor's materials, goods, and other things necessary and reasonable for vending at the location.
2. Vendor shall not vend any goods or services other than those described without the Host's written consent.
3. Vendor's vending station including tent shall be no larger than **a single parking space**; shall be clean and orderly; and shall comply with all applicable laws and regulations of Lower Allen Township.
4. Vendor's staff may announce the availability of the goods to be vended only while they are within the confines of the vendor's location.
5. Vendor's staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly fashion.
6. No loud music, noise, or sound amplification devices shall be used by vendor's staff at the location.
7. Animal-welfare organizations may display adoptable animals during the event but may not process adoptions for those animals during the event. All dogs must be leashed at all times. All cats and other small animals must remain in appropriately sized cages during the event. All animals must have access to fresh

water during the event. It is Vendor's responsibility to ensure that all animal areas are clean throughout the event and that all dog feces is immediately bagged and discarded in approved containers.

7. Vendor shall have access to the location for 1 hour after the event's conclusion to dismantle and remove all things brought to the location by Vendor. Vendor shall leave the location clean of trash and substantially in the condition it was before Vendor occupied it.

8. Vendor hereby agrees to indemnify and hold harmless the Host against any damages or claims that may arise in connection with Vendor's presence at the event and Vendor's activities of any kind.
